Participation in the Kindness Cash Challenge is open to Marshall Community Credit Union (MCCU) members ages 12–17. MCCU employees and officials, as well as their families and household members are not eligible to win. Selected participants will receive \$160 to complete a kindness-based project and are required to submit a project summary, at least one photo, and receipts for how the funds were used by the stated deadline. MCCU reserves the right to withhold or cancel awards in cases of suspected fraud, misuse, or failure to complete the project as proposed. Participants who do not submit the required documentation may be ineligible for future MCCU youth programs, prizes, or reimbursements. Funds will be deposited into the members primary savings account after award notification. Funds are provided as a gesture of community support and must be used as outlined in the approved application. Submissions found to be misleading, misrepresentative, or inconsistent with the purpose of the program may result in disqualification. MCCU has the sole discretion to investigate and determine eligibility as well as request additional information or verification before disbursing or after awarding funds. To establish a youth membership, a youth savings account must be opened with a minimum \$5 share deposit. MCCU is federally insured by NCUA.
