



## **First Capital Federal Credit Union Scholarship Program In Honor of Dennis Flickinger**

In the spring of 2025, First Capital Federal Credit Union will award FOUR Dennis Flickinger Honorable Scholarships - 2 for \$2,000, 2 for \$1,000. Dennis retired from First Capital in 2015 after serving as President/CEO for 26 years. Dennis advocated for financial education in schools and worked tirelessly to promote Credit Unions as a better choice.

The scholarships will be awarded to students who graduate from a York County high school (including homeschooled students) in this current school year (2024/25), is a credit union member by date of application, and plans to attend an institution of higher learning (accredited two- or four-year degree program) in the fall of 2025.

Applications will not be accepted for those enrolled as part-time students or for those taking adult remedial education courses.

Completed applications must be received at the address below or received via email by April 4, 2025 and must include all requested items in order to be considered.

All applications will be judged on a 100 point system:

0-50 points	Essay
0-20 points	Academic Achievement
0-20 points	Participation in Extracurricular Activities in School & Community
0- 5 points	Letters of Reference
0- 5 points	Membership Tenure

Total: 0-100 points

6. Write a Scholarship Essay: In 500 to 1,000 words, please address this question in your essay. **Credit unions are not-for-profit financial institutions designed to serve their members. How can First Capital Federal Credit Union better appeal to and serve its younger members.**
7. Submit your completed application along with the above requested items by April 4, 2025. **All requested information must be included. Incomplete or late applications will be disqualified.**
