## 90th Anniversary New Member Promotion

### Official Terms & Conditions

#### 1. Sponsor

The 90th Anniversary New Member Promotion ("Promotion") is sponsored solely by **Nordstrom Federal Credit Union** ("Sponsor"), located at 2701 Hoyt Avenue, Everett, WA 98201. This Promotion is not sponsored, endorsed, administered by, affiliated with, or associated with Nordstrom, Inc.

#### 2. Eligibility

The Promotion is open to legal residents of the United States who:

- Are 18 years of age or older;
- Are eligible for membership at Nordstrom Federal Credit Union; and
- Are not current or previous members of Nordstrom Federal Credit Union.

Employees of Nordstrom Federal Credit Union are not eligible to participate. Void where prohibited by law.

#### 3. Promotion Period

The Promotion begins at 12:00 a.m. Pacific Time on **August 1, 2026**, and continues until the first ninety (90) eligible members have qualified for the incentive or available promotional funds have been exhausted, whichever occurs first.

#### 4. How to Qualify

To qualify for the Promotion, eligible individuals must:

1. Open a Membership Savings Account with Nordstrom Federal Credit Union; and
2. Open either:
  - a checking account, or
  - a loan

during the Promotion Period.

Only the first ninety (90) eligible new members who satisfy all promotion requirements will receive the incentive.

Limit one (1) incentive per eligible new member.



## **5. Incentive**

Qualified participants will receive a \$90 promotional incentive, which will be deposited into the member's Membership Savings Account after all account opening requirements have been completed and verified.

Accounts must remain open and in good standing at the time the incentive is deposited.

The incentive is non-transferable, and no cash alternative will be provided.

## **6. General Conditions**

By participating in this Promotion, participants agree to be bound by these Official Terms and the decisions of Nordstrom Federal Credit Union, which are final in all matters relating to the Promotion.
