Savings In Style Sweepstakes 2021 Official Rules

Eligibility: NO PURCHASE, ACCOUNT OR TRANSACTION NECESSARY TO ENTER OR WIN. A purchase or any other bank transaction will not increase your chances of winning. Sweepstakes subject to all federal, state and local laws and regulations. Random Drawings will be conducted by MUTUAL CREDIT UNION by 5/15/2021.

Odds: Actual odds of winning any one (1) prize will depend on the total number of eligible entries received for each Sweepstakes Entry Period.
