Savings Never Goes Extinct Sweepstakes 2021 Official Rules

How to Enter: NO ACTUAL PURCHASE, ACCOUNT OR TRANSACTION IS REQUIRED to enter the Sweepstakes. Winner need not be present to win but must prove eligibility to receive prize. Mailed entries must be received within one (1) week of postmark date. Eligibility: NO PURCHASE, ACCOUNT OR TRANSACTION NECESSARY TO ENTER OR WIN. A purchase or any other bank transaction will not increase your chances of winning. Sweepstakes subject to all federal, state and local laws and regulations. Sweepstakes is open only to legal U.S. residents currently residing in MISSISSIPPI who are 18 years of age or older at time of entry. Void where prohibited or otherwise restricted by law. All non-winning entries will not be carried over into any subsequent Sweepstakes Entry Periods. U.S. Mail entries will be entered into the Sweepstakes Entry Period for which the entry is postmarked and received within one (1) week of postmark date. Random Drawings will be conducted by MUTUAL CREDIT UNION by 5/15/2021.

Odds: Actual odds of winning any one (1) prize will depend on the total number of eligible entries received for each Sweepstakes Entry Period.

Prizes: Ten (10) Grand Prize Winners: A check in an amount up to a maximum of \$150 for each of the 10 selected winners.
