The results of calendar year 2018 reflect the greatest performance in virtually every category of our 46 years of doing business. With total net earnings of nearly \$55 million and total assets of \$3.8 billion, we are encouraged that our favorable growth will continue.

Our outside consulting firm, Sheshunoff and Company, prepares quarterly, independent appraisals of Alpine Bank's 'A' and 'B' shares for the Employee Stock Ownership Plan. Their valuation on December 31, 2018, was \$5,350 per share for both classes of stock. This reflects an 8.9% increase over December 2017's valuation. While our growth in earnings and deposits would normally justify a higher number, our comparison with publicly held companies allows only a small increase over our 3rd quarter appraisal.




