TIPS & TRENDS

CORPORATE TRANSPARENCY ACT (CTA)

Congress enacted the Corporate Transparency Act (CTA) in 2021. The CTA creates a Beneficial Ownership Information (BOI) reporting requirement as part of the U.S. government's efforts to deter bad actors from hiding or benefitting from their illgotten gains through shell companies or other opaque ownership structures. The new requirement went into effect on January 1st, 2024. Companies required to adhere to the new BOI reporting rule must report the information to the Financial Crimes Enforcement Network (FinCEN), a bureau of the U.S. Department of the Treasury.

All businesses, unless otherwise exempted, have the responsibility to file BOI to FinCEN. Banks, including CBAZ, Bank 34, and the soon-to-beformed new institution, still have a regulatory requirement to adhere to the Customer Due Diligence (CDD) rule and its beneficial ownership reporting requirements. Current and prospective Bank clients will continue to be required to complete a Certification of Beneficial Ownership.
