Important Account Notice

Our Share Draft Checking account has received an upgrade and we are excited to announce our HFCU Free Checking accounts! It's straightforward checking for your busy lifestyle.

Effective April 1, 2021, all Kasasa Cash Back Checking accounts that do not qualify for rewards after four qualification cycles will be switched to our HFCU Free Checking accounts. Members will receive a 30-day notice regarding this switch and can opt-in to a Kasasa Checking account again at any time. With this switch, your account will remain the same with no disruption to you! You will maintain the same account number and additional services like checks, debit cards, etc. will remain unaffected. We will simply switch your account from a Kasasa Checking to an HFCU Free Checking. With our HFCU Free Checking accounts, there will be NO fees for the switch, no minimum balance, and no monthly maintenance fees. Our HFCU Free Checking accounts do not offer rewards.
