



Premier Club Memphis to New Orleans

7 Days, 6 Nights
February 19 – 25, 2022



Day One – Saturday, February 19th: Memphis (D)



Transfer to the Boise airport for departure to Memphis. On arrival, meet your tour director and take the short ride to your hotel. Check in for the next two nights before heading to dinner at Central BBQ. Central has won the famous Memphis in May cook-off several times and serves up local favorites.

Day Two – Sunday, February 20th: Sightseeing & the King (B, D)

A local guide gives you a music-based tour of Memphis. Sights include the Pyramid, Forrest Park, the National Civil Rights Museum, Museum of Rock and Soul, the Peabody Hotel with its Marching Ducks, and more. Later, tour historic Sun Studio where Elvis Presley got his start and where he recorded as part of the Million Dollar Quartet along with Johnny Cash, Jerry Lee Lewis and Carl Perkins. This afternoon take in the home of Elvis at Graceland. The audio tour provides insight to Elvis's life and music. Dinner is served at the Majestic Grill.



Day Three – Monday, February 21st: Vicksburg & Natchez (B, D)

Depart Memphis and travel south into Mississippi. Visit the Civil War battlefield at Vicksburg. The US Army under General Grant laid siege to the city for 45 days before it surrendered. Once in their hands, the Union army controlled all the Mississippi River and divided the Confederacy in half. Continue to the town of Natchez. Once the richest city in America due to wealthy landowners, it survived the war mostly intact since there were no defensive positions in the area. The town has more antebellum buildings than any other location in the South; you will tour three of its beautiful antebellum homes. Check into your hotel for the night then step back in time as you dine in an antebellum home complete with entertainment.



Day Four – Tuesday, February 22nd: New Orleans (B, D)

It is Mardi Gras season in Louisiana! Travel to New Orleans today with a stop in bayou country for a swamp tour. Your captain points out the wildlife and native plants as you cruise waters filled with majestic cypress trees and Spanish moss. Continue to New Orleans and check into your downtown hotel for the next three nights. Experience the wonder of Cajun and creole foods prepared by local chefs at the School of Cooking.



Day Five – Wednesday, February 23rd: New Orleans Sightseeing (B)

A local New Orleans guide provides a look at the Crescent City today. Some of the points of interest are the French Quarter, the French Market, Jackson Square, St. Louis Cathedral, the Superdome, the Old Mint and the Garden District with its beautiful homes and churches. Dinner is on your own this evening before meeting in the lobby for a short walk up St. Charles Avenue to our reserved seats for this evening's parade. During Mardi Gras season more than 80 krewes take part in parades in the city and the nearby towns. Enjoy the fun as they roll along tossing beads and other items.



Day Six – Thursday, February 24th: World War II Museum (B, D)

Your coach takes you on a short ride to the World War II Museum. This large campus pays tribute to the men and women that served our nation during wartime. There are sections devoted to the war in Europe and the Pacific. You will also see the 4-D presentation called “Beyond All Boundaries” narrated by Tom Hanks. The afternoon is free to relax, shop, and explore. This evening enjoy a farewell dinner at Tujague’s Restaurant, the second oldest restaurant in the French Quarter.



Day Seven – Friday, February 25th: Homeward Bound (B)

Bid farewell to New Orleans as you transfer to the airport for your flight back to Boise. Upon arrival, transfer back home where your Memphis to New Orleans Tour concludes.

LEVEL 1:

I like to keep walking to a minimum and avoiding stairs when I can. I can walk up to a mile per day over primarily level ground with short periods of standing.

LEVEL 2:

I'm comfortable walking one to two miles throughout the day. I expect to get on and off of a motor coach, and I'm ready to stroll through cities and walk over uneven pavement. I can stand for up to 30 minutes and climb one to two flights of stairs.

LEVEL 3:

I like to spend much of the day exploring and be out and about on a coach with my days full. I can walk two to three miles per day and stand for long periods of time with no difficulty. Stairs don't bother me, and I love to keep up with the group.

LEVEL 4:

I am a fit traveler and am capable of easily walking three miles or more during the day. I would like my days to be filled with active pursuits for one to three hours at a time. I can walk on uneven and rocky terrain, including small hills.

LEVEL 5:

Walking is the best way to get to know a new place. I'm energetic and enjoy a challenge. I'm always ready to spend the day on the move. I am fine with uneven surfaces, inclines, stair climbing, windy or wet conditions at sites, and long periods of standing. I expect some of the experiences to occur in the evening with very long days.

Memphis to New Orleans has an activity **LEVEL of 3.**
