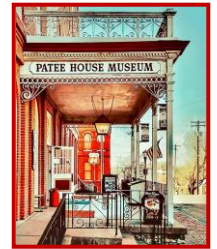
Day One: Wednesday, May 16 – Kansas City, Missouri (L, D)



Transfer to the Boise airport for departure to Kansas City, Missouri. Arrive early afternoon and head to the Arabia Steamboat Museum with lunch on the way. The Arabia was a steamboat that sank in the Missouri River in 1856. This museum is home to many artifacts salvaged from the wreck. You'll have time to check into your hotel and freshen up before dinner and a show at New Theatre & Restaurant.

Day Two: Thursday, May 17 – St. Joseph, Missouri (B, D)

After breakfast at your hotel, travel to St. Joseph, Missouri and visit the Walter Cronkite Museum and the Pony Express National Museum. The museum is housed in a surviving portion of the Pike's Peak Stables from which westward-bound Pony Express riders set out on their journey. There will be time for lunch on your own before a tour of the Patee House Museum and Jesse James' Home. This is the home where outlaw Jesse James was living at the time of his death in 1882. Later this afternoon, you will tour the Tobias Stained Glass Studio and have time for a special project. Dinner is at the JC Wyatt house this evening which is an elegant 1891 home with victorian antiques. After dinner, return to your hotel in Kansas City.



Day Three: Friday, May 18 – Branson, Missouri (B, D)

Enjoy your last breakfast in Kansas City before visiting the Harry S. Truman Presidential Library and Museum in Independence, Missouri. Harry S. Truman was a Midwestern farm boy and assumed the presidency in the final months of World War II. This museum highlights the major issues and events of Harry Truman's life and presidency. After the Library, make your way to Branson with lunch on your own en route. You'll have time to check in and freshen up at the hotel in Branson or enjoy shopping on your own before dinner this evening. After dinner, enjoy the show *Clay Cooper's Country Express*. This show features an incredible cast of dancers, singers, and musicians that will capture your attention. If you are a music lover or just love good entertainment, this is a show you've got to see!



Day Four: Saturday, May 19 – Branson (B, L, D)

After a delicious breakfast at your hotel, visit Dogwood Canyon. Located in Lampe, Missouri, Dogwood Canyon Nature Park is a 10,000-acre outdoor playground. Step aboard the comfortable, open-air tram and explore the beauty. This adventure includes a narrated tour of the park as you pass by bluffs, waterfalls, and other scenic views. Plus, you'll cross the Arkansas border and enter the Bison-Elk Country pasture, encountering the largest residents at Dogwood Canyon. Lunch is included at the Mill & Canyon Grill Restaurant. After lunch see *#1 Hits of the 60's*. This show was voted "Branson's Show of the Year". *#1 Hits of the 60's* touches on over 115 songs from the great artists of the 50's, 60's, and 70's and includes over 100 costume changes. Enjoy a fantastic dinner and then an evening show TBD.



Day Five: Sunday, May 20 – St. Charles, Missouri (B, D)

Breakfast is included at your Branson hotel this morning before we depart for St. Charles, Missouri. You will have a city tour upon arrival in St. Charles with lunch on your own. Located on the Missouri River northwest of St. Louis, St. Charles rewards its guests with a unique fusion of past and present. Founded over 250 years ago, the community flourishes around the authentic ambiance of its Main Street Historic District. Visit the Lewis & Clark Nature Center and Boathouse and then enjoy time on your own to explore St. Charles' great downtown and shopping. The Boathouse and Museum commemorates Lewis & Clark's journey of discovery in 1804. The frontier town of St. Charles was the last civilized outpost before entering a vast untamed territory. After dinner, we'll make our way to Hannibal, Missouri and check into our hotel for two nights.



Day Six: Monday, May 21 – Hannibal, Missouri (B, D)

After breakfast at the hotel, we'll make our way to Mark Twain's Boyhood Home & Museum. Explore the roots of Twain's genius as you discover how a young boy from a small river town became America's most beloved author and humorist. See the Mark Twain Boyhood Home, a National Historic Landmark, the Becky Thatcher House, Huckleberry Finn House, J.M. Clemens Justice of the Peace Office, the newly reopened Grant's Drug Store, Museum Gallery, and Interpretive Center. Traverse the labyrinth which inspired Mark Twain's famous work, *The Adventures of Tom Sawyer*, on a guided tour of the Mark Twain Cave. Enjoy a wine tasting at Cave Hollow Winery before a sightseeing cruise on the Mark Twain Riverboat.



Day Seven: Tuesday, May 22 – St. Louis & Homeward Bound (B)

This morning we'll motorcoach to St. Louis and visit the Gateway Arch. The Gateway Arch reflects St. Louis' role in the Westward Expansion of the United States during the nineteenth century. The Park is a memorial to Thomas Jefferson's role in opening the West, to the pioneers who helped shape its history, and to Dred Scott who sued for his freedom in the Old Courthouse. We will have lunch on our own and a quick tour of the city before we check into the airport for our late afternoon return flight home.

LEVEL 1:

I like to keep walking to a minimum and avoiding stairs when I can. I can walk up to a mile per day over primarily level ground with short periods of standing.

LEVEL 2:

I'm comfortable walking one to two miles throughout the day. I expect to get on and off of a motor coach, and I'm ready to stroll through cities and walk over uneven pavement. I can stand for up to 30 minutes and climb one to two flights of stairs.

LEVEL 3:

I like to spend much of the day exploring and be out and about on a coach with my days full. I can walk two to three miles per day and stand for long periods of time with no difficulty. Stairs don't bother me, and I love to keep up with the group.

LEVEL 4:

I am a fit traveler and am capable of easily walking three miles or more during the day. I would like my days to be filled with active pursuits for one to three hours at a time. I can walk on uneven and rocky terrain, including small hills.

LEVEL 5:

Walking is the best way to get to know a new place. I'm energetic and enjoy a challenge. I'm always ready to spend the day on the move. I am fine with uneven surfaces, inclines, stair climbing, windy or wet conditions at sites, and long periods of standing. I expect some of the experiences to occur in the evening with very long days.
