July 22 – 30, 2024

Day One: Monday, July 22 – Boise, Idaho

Start the afternoon in Eastern Idaho and pick up members throughout Southern Idaho on the way to Boise. You will then arrive at the Hampton Inn Boise Spectrum. The evening is yours to relax at the hotel and enjoy dinner on your own before beginning your “Splendors of North Idaho & Montana” Tour.



Day Two: Tuesday, July 23 – Lewiston, Idaho (B, D)

After breakfast at the hotel, you’ll pick up our Treasure Valley friends and travel north. On the way, we’ll stop in beautiful McCall for lunch and time on your own. Visit the fun shops downtown, enjoy the views of Payette Lake, or visit Ice Cream Alley for an after-lunch treat! Later, board the motorcoach and make your way to Idaho Territory’s first capital, Lewiston, Idaho. Check into your room at the Hampton Inn & Suites before enjoying a dinner together at a local steakhouse with sweeping views of the valley.



Day Three: Wednesday, July 24 – Sandpoint, Idaho (B, D)

Today, continue traveling north and stop in Coeur d’Alene for lunch and time on your own. The scenic Coeur d’Alene Resort boasts beautiful views of Lake Coeur d’Alene’s pristine waters and majestic mountains and has many shops and restaurants to visit. You may also choose to take a stroll around the boardwalk or visit City Park. As you cross the Long Bridge, you’ll see incredible views of Lake Pend Oreille, Sandpoint, Schweitzer, and the Selkirk Mountain range. Arrive at the Edgewater Resort in Sandpoint early afternoon with time to check in and relax before dinner in downtown Sandpoint together.



Day Four: Thursday, July 25 – Sandpoint, Idaho (B)

This morning, make your way to Idaho’s largest resort, Schweitzer Mountain. Experience a scenic ride on Schweitzer’s longest chairlift; ride up the Grand Escape Quad and arrive at an elevation of 6,400 ft. You can take in the views of 3 states, Canada, and Lake Pend Oreille. There is time to stop into Sky House for a bite to eat or refreshing drink on the deck before making your way back down the mountain. You can enjoy time at the hotel or in downtown Sandpoint with an early dinner on your own. The evening will be spent aboard the Shownodese during a Lake Pend Oreille Cruise. We will cruise during sunset and even have the chance to see bald eagles!



Day Five: Friday, July 26 – Wallace, ID to Missoula, Montana (B)

After an early breakfast at the hotel, board the motorcoach and say “good-bye” to Sandpoint. Start your drive southeast and head to historic Wallace, Idaho. Begin your journey with a guided tour of Wallace aboard a classic trolley before you adventure underground in the Sierra Silver Mine. After the tour, you’ll have time for lunch and shopping on your own before we leave Wallace. Experience the beautiful drive into Missoula, Montana and arrive at the Double Tree by Hilton hotel situated on the Clark Fork River in the late afternoon. The evening and dinner are on your own and can be spent enjoying the beautiful views of the river, taking a short walk downtown, or having dinner at the on-site restaurant.



Day Six: Saturday, July 27 – Missoula to Bozeman, Montana (B, L, D)

Your full Montana day begins after an early breakfast at the hotel! Wide open spaces, the hard-working cowboy, his spirited cow pony, and vast herds of cattle are among the strongest symbols of the American West. Once the headquarters of a 10-million-acre cattle empire, the Grant-Kohrs Ranch National Historic Site preserves these symbols and commemorates the role of cattlemen in American History. You will have time on your own to experience a historic tour, see living history demonstrations, or visit the many buildings. Then, end the visit with a picnic lunch. Next, make your way to Butte for a historic trolley tour. You’ll learn about Butte’s rich mining and cultural history, which dates to the middle of the 19th century. End your day’s travels in Bozeman, Montana and have dinner together at a casual brewery with patio views of the mountains.



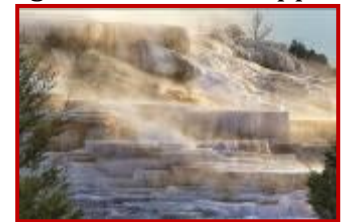
Day Seven: Sunday, July 28 – Bozeman to West Yellowstone, Montana (B, L)

Discover a world of captivating exhibitions at the Museum of the Rockies today. There are three to five changing exhibits each year designed to engage members and visitors of all ages. The museum’s extensive collection of dinosaur fossils, including one of the largest and most important in the United States, is a rare insight into the prehistoric world. After the museum, you will have lunch together at a local restaurant before traveling to West Yellowstone, Montana. Check into the Gray Wolf Inn & Suites for two nights and enjoy dinner on your own this evening.



Day Eight: Monday, July 29 – Yellowstone National Park (B, L, D)

Rise early today and board the Yellowstone Tour Bus. Today, you will be visiting Yellowstone’s Upper Loop. The Upper Loop takes you through some of the most scenic parts of Yellowstone National Park, offers great wildlife watching, and unique thermal features. This tour might include sites such as: Norris Geyser Basin, Lamar Valley, Obsidian Cliff, Mammoth Hot Springs, Gibbon Falls, and Tower Fall. After a full day in the park, there will be a farewell pizza party at the hotel this evening.



Day Nine: Tuesday, July 30 – Home (B)

After breakfast at the hotel, make your way home dropping our Eastern Idaho friends off in the morning, before heading to Mini-Cassia and Magic Valley. The Treasure Valley Premier Club members will have lunch on your own in Twin Falls before arriving home in the late afternoon.

I like to keep walking to a minimum and avoiding stairs when I can. I can walk up to a mile per day over primarily level ground with short periods of standing.

LEVEL 2:

I'm comfortable walking one to two miles throughout the day. I expect to get on and off a motor coach, and I'm ready to stroll through cities and walk over uneven pavement. I can stand for up to 30 minutes and climb one to two flights of stairs.

LEVEL 3:

I like to spend much of the day exploring and be out and about on a coach with my days full. I can walk two to three miles per day and stand for long periods of time with no difficulty. Stairs don't bother me, and I love to keep up with the group.

LEVEL 4:

I am a fit traveler and am capable of easily walking three miles or more during the day. I would like my days to be filled with active pursuits for one to three hours at a time. I can walk on uneven and rocky terrain, including small hills.

LEVEL 5:

Walking is the best way to get to know a new place. I'm energetic and enjoy a challenge. I'm always ready to spend the day on the move. I am fine with uneven surfaces, inclines, stair climbing, windy or wet conditions at sites, and long periods of standing. I expect some of the experiences to occur in the evening with very long days.
