The interest rate is 3.50% APR; if the payment is made from an automatic transfer from a MariSol account or by an electronic transfer, then a 1.00% discount will apply, the rate will be reduced to 2.50%. The payment on a \$20,000 loan at 2.50% for 48 months is \$438.30. Rates for auto loans can be adjusted for factors such as model year, term, loan to value and excessive mileage. ## Quickly Transfer Funds between MariSol and Other Banks or Credit Unions

MariSol members can now transfer funds to and from other U.S. financial institutions using our Online and Mobile Banking platform. **It is a FREE service!** 

Here's how to set up Account to Account Transfers (A2A):

- Visit www.marisolcu.org then log in to your MariSol Online Banking Account.
- Click on the Accounts tab in the upper left corner, then select Account to Account Transfer (A2A) from the drop-down menu.
  - You will need the External institution's routing number, and a checking or savings account number (information available on a check).
  - Once you enter the information, MariSol will generate two micro-deposits (under \$1.00) and send them to your External Account, which may take up to 48 hours.
  - After the deposits are posted, log back into online banking, verify these amounts before you begin transferring money to or from the External Account.
