

## **FCCU NextGen Giveaway Official Rules**

### **1. Eligibility**

The FCCU NextGen Giveaway ("Giveaway") is open to legal residents of the United States, between the ages of 18 and 24, as of August 18, 2025. Employees, officers, and directors of FCCU, its subsidiaries, affiliates, advertising and promotion agencies, and immediate family members (spouse, parents, siblings, and children) or members of the same household are not eligible to participate.

### **2. Promotion Period**

Mail-in entries must be postmarked by September 30, 2025 and received by October 4, 2025.

Limit one (1) entry per person, regardless of entry method.

Five (5) winners will each receive one (1) \$100 DoorDash gift card. Approximate Retail Value ("ARV") of each prize: \$100. Total prize pool ARV: \$500. Prizes are non-transferable, non-exchangeable, and may not be substituted except by FCCU at its sole discretion.

Winners will be selected in a random drawing conducted by FCCU within one (1) week after the Promotion Period ends. Odds of winning depend on the number of eligible entries received. Winners will be notified by e-mail and/or phone using the contact information provided at entry. If a winner cannot be contacted within seven (7) days, or is disqualified, the prize may be forfeited and an alternate winner selected.
